#### **I. Course Description**

Applied voice is the concentrated, individualized study of singing which includes learning technique, literature, and performance skills. Principles of vocal technique, both historic and contemporary, will be studied alongside literature appropriate for the developmental level of each student. Repertoire in multiple languages as well as multiple style periods will be studied. Additionally, throughout this virtual semester, students will explore best practices in online audition submissions, recording the process and development utilizing an e-portfolio. Submissions to this e-portfolio may also serve as jury videos, in the even

#### **II. Course Objective Outcomes**

- 1) Students completing this course will, above all else, develop their vocal technique in order to sing with freedom. (MLO 3,4, 5; RU 2)
- 2) Technical attention will be focused on, but not limited to, posture, airflow, registration, placement, diction, and interpretation. (MLO 2, 3, 4; RU 2)
- 3) Each student will grow in his/her ability and confidence as a performer. In lieu of live performances, should none be available, I will accept one viewing of a Metropolitan Opera broadcast. Please submit what you watched, along with a one-paragraph critique.. (MLO 3,4, 5; RU 2)
- 4) Students will gain knowledge of the historical and biographical background of each piece of music assigned, and will memorize the translations of any assigned foreign language piece(s). (MLO 2; RU 2, 4)
- 5) Students will develop their technical skills, enabling them to produce high quality video auditions at industry standard. (SLO 1, 2, 4, 5)

### III. Course Requirements

1. Students will obtain original music for any assigned repertoire and provide copies of all assigned repertoire for their accompanists by the third week of classes
2. Students are expected to come to each lesson on time, warmed-up, and prepared with a new **memorized** song, until all repertoire has been learned (whether F2F or online)
3. Students are expected to maintain an active practice regimen (1 to 1 1/2 hours per day)
4. Students are expected to record each lesson and practice with the recorded lessons
5. Students are expected to attend at least one studio class per week
6. Students are required to sing in at least one student recital each semester (recorded submissions will be accepted in lieu of live performances until further notice)
7. Vocal Performance and Musical Theater majors are expected to participate in GANATS and SERNATS; Vocal Music Education Students are expected to participate in either GANATS or SERNATS, and encouraged to participate in both. (Online until further notice)

### IV. Attendance

Attendance: Students are expected to attend classes. Students are excused when they are sick (**please DO NOT attend in person with headache, fever, runny nose/congestion, sore throat, cough, or nausea/vomiting**)—we can meet online instead, if your singing voice is unaffected, or reschedule for another day. The instructor needs to be notified via telephone (cell number) **prior** to the missed lesson, or when they are required to participate in an event in which they officially represent the University. Three (3) tardies constitute one unexcused absence.

### V. Attire

Appropriate and professional attire is expected at all lessons, rehearsals, studio classes, and performances. For example, no sweats or lounge wear should be worn during lessons. If you are coming directly to a lesson from a dance class, please bring an appropriate cover up.

Attire for studio class should be dressy – appropriate for an audition or interview.

### VI. Performance/Juries

Applied voice students are required to sing a set number of songs from memory at juries. Freshmen are required to prepare 4-6 songs for memory, while Sophomores, Juniors, and Seniors are required to prepare 6-8 songs for memory. A principal role in either an opera or musical theatre production can count for up to 2 jury selections as determined by the instructor. Voice majors must sing on a departmental recital every semester (to be determined). Voice minors may or may not perform on departmental recitals but must meet all other departmental performance standards. Voice majors should discuss requirements for junior and senior recitals with the instructor.

Additionally, the following requirements apply:

#### **Bachelor of Fine Arts Musical Theatre Majors:**

Freshmen: Minimum 1 Art Song; Minimum 2 Golden Age Pieces (per semester)

Sophomores: Minimum 3 Golden Age Pieces (per semester)

Juniors/Seniors: Repertoire to be determined by applied instructor

\*You must have entire audition book ready (with résumé and headshot) and random pieces will be selected

**Vocal Performance, Vocal Music Education, and Bachelor of Arts Majors:**

Freshmen: Between 4-6 Art Songs and/or Arias (per semester)

Sophomores/Juniors/Seniors: Between 6-8 Art Songs and/or Arias (per semester)

\*In some cases, up to two musical theatre selections may be substituted

Senior Fall Jury: Must present 75-150 word bio, headshot, and résumé

**VII. Reflections:**

Students may submit lesson reflections for each lesson (weekly) for 10 percentage points of extra credit. Extra credit will be applied to your weekly lesson grade.

**Lesson Reflections (due via email 48 hours after your lesson):**

- 1) Lesson Summary (what you take away from this lesson):
- 2) What did you find most beneficial during this lesson (light bulb moments)?
- 3) List 3 vocal exercises utilized and describe your understanding of the purpose of each:
- 4) Which technical suggestions from this lesson will you work to implement this week?
- 5) What could have made this lesson more beneficial?
- 6) What vocal technique and/or expressive questions do you have that remain unanswered?
- 7) Are you enjoying your repertoire? If not, what might you like to be different about it?

**VIII. Studio Class**

In addition to regular lessons, students are expected to attend studio class which will meet every Thursday, from 3:30-4:30 PM, on a Band Room/Choir Room/207 rotation (see posted schedule). A second studio class will meet weekly on Fridays, in the Choir Room, from 11:00 AM – 11:45 AM.

**Attendance is required of all majors** at one or both classes unless they have a class conflict.

Work schedules should be arranged so as to be available to attend at least one studio class per week (remember that you are a student first). Acceptable excuses for missing studio class are the same as those for missing lessons.

**IX. Required Vocal Events**

All Voice Performance, Music Education, Sacred Music, and Musical Theatre majors must attend all Reinhardt student voice recitals, musical theatre showcases, visiting professional voice recitals, and voice faculty recitals. **Check check the assignments in Canvas on a weekly basis, as events will be added throughout the semester, and plan accordingly.** In addition to vocal recitals, attendance at two non-voice area recitals or concerts is required. See “Assignments” in Canvas for further directives.
